WINE TASTING PAVILION TERMS & CONDITIONS**

Pavilion Hours: Sunday, April 29, 2012 10:00—5:00 pm
Monday, April 30, 2012 10:00—4:00 pm

The Northwest Foodservice Show Agrees to Provide the Following:

- Either a 3' section of a 6' skirted counter for one server, or a 6' skirted counter for two servers, as applicable.
- Carpet for the Tasting Pavilion Space.
- An 8 1/2" x 11" T-Frame countertop sign for each company that is pouring.
- Appropriately placed trash receptacles within the Tasting Pavilion space.

The Participating Winery Agrees to the Following:

- **Class 8 Permits:** Servers must have submitted to show management, within 30 days of the show, a copy of the required Washington State Liquor Control Board Class 8 Permit. Companies must also have this permit on hand and available for presentation to a liquor control board inspector if asked for it.
- **Insurance:** The participating company must have obtained and sent to Show management proof of a liquor liability endorsement of no less than \$1 million, naming Northwest Foodservice Show as an additional insured party.
- **Sample Sizes:** Sample sizes are restricted to the following as per WSLCB requirements:
 - Beer:** Not to exceed 2 ounces per serving.
 - Wine:** Not to exceed 2 ounces per serving.
 - Liquor:** Not to exceed 1/2 ounce per serving.
- **Compliance with NWFS Rules and Regulations, and City, State & Federal Laws**

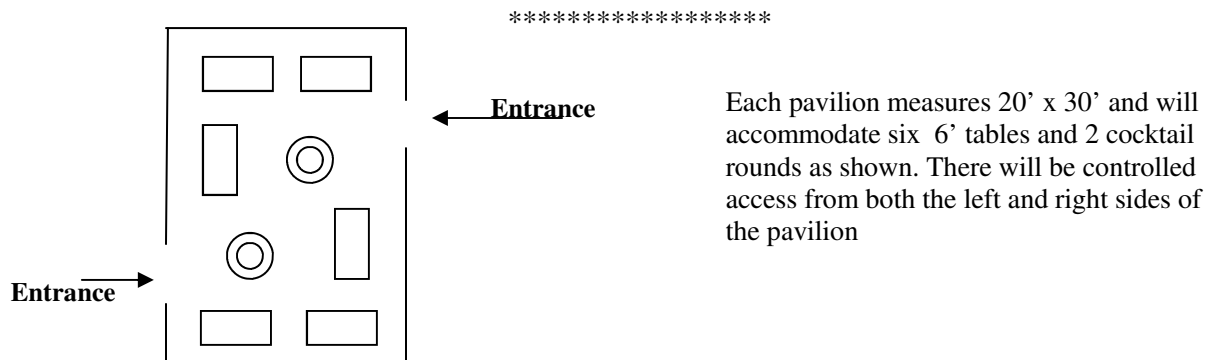
All Tasting Pavilion participating companies must adhere to all show policies, and city, state and federal laws governing the serving of alcoholic beverages. Exhibitor agrees to hold harmless and indemnify Show Management and all agents of the Northwest Foodservice Show for any fines or penalties resulting from Exhibitor non-compliance or violation of alcohol serving rules and regulations, or city, state or federal laws.

Please Note! Ice is not provided by show management. Participants will have the opportunity to order ice prior to the show as an exhibitor service for delivery to the Tasting Pavilion, or they may provide their own. Also note that utilities including electrical services, plumbing including water or drain hook-ups, or telecommunications services are not provided, but will be made available as an exhibitor service for any participants who may require them.

Cancellations & Refunds

Cancellations of the Pavilion must be received in writing. Cancellations received prior to Jan. 31, 2012 will receive a 50% refund for space reserved. Cancellations received after this date will forfeit the full cost of the Pavilion space.

Pavilion Layout



Each pavilion measures 20' x 30' and will accommodate six 6' tables and 2 cocktail rounds as shown. There will be controlled access from both the left and right sides of the pavilion
